2025-2026 Call for Officers



It is that time of year to begin thinking about who you want to see leading the club for the next fiscal year. We do have a few known individuals that will be stepping back from their present roles. We want to take the opportunity to invite you to participate in the club from a leadership perspective. We hope to share a little of what to expect, to aid you in your decision to step up. Your help is needed and wanted.

The roles of President and Vice-President, are largely political positions where you are the “face” of the club.

Time requirements are minimal dependent upon the level of involvement you want. Doing the bare minimum, you lead the Aerie meetings on a twice a month basis. If you wanted to really embrace the role, there are division, zone, state and other meetings in which the President is strongly encouraged to participate as well. The President appoints committee members as needed.

The Secretary role is far more involved. The Secretary is also a member of the Board of Trustees. This role has a two-year time commitment and requires a deeper level of involvement as this role is the information source of the club. The Secretary is the primary point of contact for hall rentals, club events, and minute taking to name a few responsibilities. The Secretary also processes membership applications and prints membership cards. For more information on this role, we encourage you to talk with the current Secretary.

The Treasurer is a vital role and a position of trust. As treasurer you will be directly responsible for working with the Secretary to make bank deposits, pay the bills, manage the budget, record bar sales and ensure that everything balances out at the end of the month. This is another role that requires a bit more of time and attention. We invite you to speak with the current Treasurer for more details.

Chaplin, Inside Guard, and Conductor roles are like the Presidential and Vice-Presidential roles. The primary function in these roles is to facilitate the Aerie meetings. If you choose to be more involved than the twice monthly meetings, we whole heartedly welcome you.

Trustees are directly responsible for the day-to-day operations of the club. The Trustees meet every week to discuss club business. In this role you would have an impact on what decisions are made, projects to pursue or to leave behind, direct funding, and so forth. The Trustee’s have the primary responsibility to ensure the continued operations of business from ensuring the buildings security to scheduling a fun activity. This is the most involved role which calls for the biggest time commitment. This is a challenging yet rewarding role as you serve the club and its members.
